




### WHAT DID PR4 CONSIST OF?



## PROJECT MEETING



Last June, the **final face-to-face meeting of the GREEN Factor project** was held in Valencia (Spain), bringing together partners from Italy, Spain, Greece, Czech Republic and France. It was hosted by Kveloce, one of the Spanish partners.

The partners met and discussed the main achievements of the project, as well as the remaining tasks and the next steps until the closure of the project on 31 October 2024.

In this recent final meeting of the Green Factor project in Valencia, held on 11-12 June 2024, we had the opportunity to share great progress.

We started talking about the Replicability Guide for Young Workers, the last result of the project, whose content was finalised in English and, as a next step, we were talking about the design of the document and its translation into several languages in order to reach more people.

Another important point of the meeting was the organisation of the project multiplier events in each of the partner countries, which will take place before 31 October 2024.

The final meeting of the Green Factor project in Valencia was a significant milestone that allowed to reflect on the achievements and set a clear path towards the completion of the project. It reaffirmed the commitment of all partners in the dissemination of the results developed throughout the project and their involvement in the organisation and holding of multiplier events, ensuring that the project results reach a wider audience.

In addition, collaboration and communication were highlighted as key pillars for continued success, and the groundwork was laid for future interactions through the next online meeting.

This meeting not only celebrated past achievements, but also inspired renewed enthusiasm for the impact the project can have on youth communities.
